# BSides Overview

## COVID-19 STATEMENT

Due to the impact from COVID we have adjusted the 2021 BSides Charlotte security conference into a virtual conference to eliminate the risk that a physical conference could pose to our attendees.

However, we also realize that this changes the make-up of our event, associated costs, opportunities for sponsors, and as a result, our sponsorship package.

While a virtual conference is significantly cheaper, there are still some associated costs that we hope to have help offsetting through sponsorship. In addition, all sponsorship dollars received this year will provide us with a strong foundation to begin planning for a 2022 physical conference.

We still believe in our collective ability to provide a valuable security conference to the local community and due to several of our board members having existing experience working with virtual events, we are confident in our ability to execute a successful virtual conference.

## Theme

This year BSides Charlotte will focus on a theme of “open mic”, welcoming any topics related to security and the InfoSec industry.

## Target Audience & Attendance

BSides attendees vary widely from students, to individuals in various IT professions, educators, executives, individuals already in the field, industry thought leaders, and more. This diversity is another key element of what makes BSides an attractive and successful event for everyone involved. While we cannot guarantee an exact attendee number for a variety of reasons, based on preliminary surveys and attendance at other conferences around the region occurring prior to our event this year, we anticipate an attendance of at least 150 and up to 300 for our one day conference.

### Terms and Conditions

1. **Sponsorship Agreement:** between the event-specific BSides Charlotte, Inc., registered 501(c)(3) non-profit organization ("Organization") and ("Sponsor") is valid from the date

it is fully executed through the end of the sponsored event (or a period specified by an addendum to this agreement).

2. **Sponsor Marketing Use Agreement:** Sponsor may use the following tag line on its marketing materials during the term of this Sponsorship Agreement: "Official Sponsor of BSides Charlotte".
3. **Production Timeline:** In order for the Organization to fulfill all promotional benefits for Sponsor, the Sponsor agrees to meet all Organizer related submission deadlines:
  - a. Trademark/Logo, Sponsor URL, Ad (if applicable), Banner display (if applicable), will be sent by the requirements specified in the sponsorship details section above.
  - b. Use of any items submitted after such a date cannot be ensured.
4. **Sponsor Trademark Usage Agreement:** Sponsor agrees to allow the Organization to use Sponsor's trademark/logo/tagline solely to perform and fulfill its obligations under the Sponsorship Tier and this Sponsorship Agreement.
5. **Sponsor Trademark Usage:** Notwithstanding Section 4 above, the Sponsor agrees to allow the Organization the right to use Sponsor's trademark/logo/tagline and graphics on all of the promotional benefits, including but not limited to:
  - a. The Web banner ad to be posted on the event and BSides Charlotte web pages and social media accounts

Failure to pay the full balance will subject sponsorship and Sponsorship Agreement to cancellation.
8. **Non-endorsement:** The use of Sponsor's name within BSides Charlotte or event-specific websites or mailing lists does not constitute endorsement by BSides Charlotte or any BSides affiliates or staff of the Sponsor's services, products, or programs. Additionally, the Sponsor is not permitted to represent in any manner that such products, services, or programs have been endorsed by BSides Charlotte, affiliates, or staff.
9. **Limited Liability:** In the event that circumstances beyond the commercially reasonable control of the Organization interferes with, or prevents, the Organization from fulfilling, in part, or all of, the Sponsor's promotional benefits under this Sponsorship Agreement, the Sponsor, by signing this Sponsorship Agreement, holds the Organization, as well as their respective Board of Directors and staff harmless from all legal and financial liability to Sponsor, caused by such circumstances, beyond the fee paid by Sponsor for this sponsorship.

12. **Entire Agreement:** This, and all attachments here to, constitute the entire Sponsorship Agreement. If one portion of this agreement is deemed to not be in effect, all other portions will remain in effect.
